Business Arising:

1.Cycle Trail: A number of residents had come to meeting to hear Nick Ross speak as hadn't heard his attendance was cancelled due to losing his house in the recent floods.

Nick had provided an update which Fiona read out.

Discussion and concern was raised from Jason and Rebecca about workers from TDC coming onto their property surveying the trail and a survey company flying a drone over their property. This was done without residents permission and without any notification. Jason and Rebecca have contacted the manager of the company and also Nick Ross without any reply at this stage.

2. Council update:

Three waters update: Christeen gave an update on the 3 Waters reform as she understands it - For Central Government, Dep't IE to take over the functions of drinking water, waste water and storm water under a new water regulator. At council meeting tomorrow 12/8, the three waters reform will

be outlined, and is displayed on TDC website. It is touted as a cheaper proposition for council to hand over debt and assets of our three waters. \$\$\$ are being given to councils who partake in this reform.

The decision for TDC to go into one of the water regulator entities needs to be made by 1st October and is needed to be In consultation with Iwi.

TDC were to have a full council meeting about 3 water reform the next day -

- 3. Antenno app: As per Council Update email from Dean, Christeen encouraged all residents (who have smart phones!) to get app on their phones for receiving easier council notifications e.g. flood warnings, road closures and public safety issues.
- 4. Pokororo swing bridge discussion and concerns raised about it's safety post flooding. Council undertaking some works
- 5. RMA review As of February 21, 3 new acts are replacing RMA after it was reviewed last year Natural and Built Environments ACT (NBA), the Strategic Planning Act (SPA) and the Climate Change Adaption Act (CAA). Concern raised about centralisation and that amalgamations will lose lots of local input.
- 6. Tasman Environment Plan, which will incorporate TDC Resource Management, will identify the district's special places. First draft maps of Tasman District's Outstanding Natural Landscapes, Outstanding Natural Features and the Coastal Environment have been out for community consultation over Autumn. After feedback, updated draft maps will be released later in the year.
- 7. Tasman Long Term Plan signed off 30th June
